Speakers looked at the increase in China's North American energy investments. As China continues to grow, its investments in North American energy will increase, providing an engine for growth in both Canada and the United States. Panelists included Wenran Jiang, University of Alberta; Bo Kong, Johns Hopkins University School of Advanced International Relations; Jeff Kucharski, Alberta Energy; Adam Lysenko, The Rhodium Group; and moderator Jennifer L. Turner, China Environment Forum.

June 14

The Impact of Local Law Enforcement at the Canada-U.S. Border

Programs such as the Beyond the Border Action Plan have significantly increased the level of communication between the United States and Canada, which will only ease the pressures faced by all law enforcement agencies that operate at and near the border. The panel looked at the importance of local law enforcement, which works with federal agencies to secure the northern border.

June 26

Our Shared Challenges: North America Environmental Roundtable Series

Co-sponsored with the Mexico Institute and the Environmental Protection Agency
The Canada Institute and the Mexico Institute of the Wilson Center inaugurated *Our Shared Challenges: North America Environmental Roundtable*, a series of targeted discussions focused on protecting human health and the environment in North America. Michelle DePass, Assistant Administrator for the United States Environmental Protection Agency's Office of International and Tribal Affairs, discussed cooperative efforts with the Commission for Environmental Cooperation.

July 9

The Beyond the Border Action Plan at Six Months

The Canada Institute hosted Alan Bersin, assistant secretary and chief diplomatic officer, Office of International Affairs, Department of Homeland Security, and David Moloney, senior advisor, Privy Council Office, to assess progress in the Beyond the Border Action Plan after six months of work. The panelists concluded that federal and local governments must work together to make border law enforcement more effective and create a freer flow of legal goods and services between the United States and Canada. Progress must be made to ensure that the Action Plan increases both security and trade for North America with sufficient buy-in from all interested parties.

July 12 **In Search of Arctic Energy**

Co-sponsored with European Studies, Program on America and the Global Economy, Environmental Change and Security Program, and Kennan Institute Panelists discussed the expansion of Arctic activity, focusing on the forces driving the increase in exploration and on what new techniques and technologies are allowing this unprecedented activity. Arctic experts examined what nations can do to protect the environment, increase production, and ensure international cooperation.

The Regulatory Cooperation Council Action Plan at Six Months

Co-sponsored with the Program on America and the Global Economy and the U.S. Chamber of Commerce The program allowed both the implementation teams and a number of stakeholders an opportunity to discuss the successes and challenges of the Regulatory Cooperation Council Action Plan. This regulatory alignment process is designed to better coordinate the regulatory regimes of the United States and Canada.

August 8

The Trans-Pacific Partnership and the Future of International Trade

Co-sponsored with the Program on America and the Global Economy, Mexico Institute, Kissinger Institute on China and the United States, Asia Program, and Latin American Program

Ambassador Demetrios Marantis, Deputy U.S. Trade Representative, opened the discussion, after which panelists discussed how the Trans-Pacific Partnership, a major trade initiative of the Obama administration, will broaden trade in the Pacific and could create a template for future, global trade negotiations.

September

September 19

<u>Terror and North America: The Causes and Directions of Cross-Border Extremist Activity</u>

Panelists examined how and why extremists travel between Canada and the United States, what effect these crossings have on risk assessment and national security, and what possible policy solutions exist to better police the border.

October

October 12

Relations with China from the Perspectives of Brazil and U.S. Global Businesses
Co-sponsored with the Brazil Institute and Kissinger Institute on China and the United
States

The discussion focused on the presence of Brazilian companies in China and the changing pattern of Chinese interests and investments in Brazil, from exporter of manufactured products to investor in industrial plants and infrastructure projects. Panelists examined the relationship from the private sector perspective and lessons learned from American and Canadian companies operating in and with China.

October 24-28

18th Inuit Studies Conference 2012

Co-sponsored with the Smithsonian Institution's Arctic Studies Center of the National Museum of Natural History

The conference covered a broad spectrum of topics, including climate change and indigenous peoples; international cooperation in the Arctic; roles of museums and museum collections in preserving Inuit languages, heritage, and culture; governmental programs in the northern regions and their interactions with local communities; and Inuit cultural/political institutions.
