Ambassador Bruce Heyman is the co-founder of Uncharted, a new venture engaging in creative philanthropy, impact investments, and political activism. There, he combines his political, economic, and charitable experience to create sustained impact among diverse communities. Most recently, he served as the United States Ambassador to Canada under President Barack Obama from 2014 until 2017. He continues his work strengthening the relationship between Canada and the United States by serving as a strategic advisor to Canada 2020, a Canadian progressive think-tank based in Ottawa, as a member of the advisory board to the Canada Institute at the Wilson Center, and as an honorary patron to the Council of the Great Lakes Region. He is also on the advisory board for Uptake in Chicago.

Ambassador Heyman is a 33 year veteran of Goldman Sachs, where he served as partner and managing director in the Chicago office. He previously served as a board member for the Chicago Council on Global Affairs and the Northwestern Memorial Hospital Foundation. He also served as an advisor to the Fix the Debt CEO Council of the Committee for a Responsible Federal Budget. He has been a member of The Executives' Club of Chicago and the Facing History and Ourselves Chicago Advisory Board.

A magna cum laude graduate with both a BA and an MBA from Vanderbilt University, Ambassador Heyman continues to maintain close ties to his alma mater. He is past president of the Alumni Board and a former member of the Board of Visitors at the university's Owen Graduate School of Management. He and his wife Vicki live in Chicago, where they celebrate their family and friendships. They have three children and three beautiful grandchildren.

Laura Dawson is Director of the Canada Institute. Named one of Canada's Top 100 foreign policy influencers by the Hill Times in 2014, Dawson is a speaker, writer, and thought leader on Canada-U.S., NAFTA, TPP, and international trade issues.
