




Quick Facts on Global Fisheries

- According to the U.N. Food and Agriculture Organization (FAO), 85% of the world's fisheries are fully exploited, overexploited, depleted or recovering from depletion.
- Employment in capture fisheries, aquaculture, and related sectors supports about 540 million people—approximately 8% of the global population.
- Seafood provides 15% of animal protein for 4.3 billion people.
- Global fishing fleet: > 4.3 million commercial vessels
- 74% operate in marine waters

Global map (A) of cumulative human impact across 20 ocean ecosystem types













The Non-tuna RFMOs

International Fisheries Management: Turning Failure into Success

Failures:

- Lack of political resolution to make difficult adjustments
- Persistence of harmful subsidies
- Lack of control on fleets by flag states
- Ineffectiveness of RFMOs
- Lack of consideration of traditional communities rights
- Success of industry lobbies in resisting change
- Lack of capacity to implement management measures



Opportunities for Success

- Growing concern for global environment
- International instruments broad agreement language on precautionary approach and ecosystem based management
- Strengthening of RFMO compliance processes
- Technology to improve data collection and combat IUU
- Increasing number of IUU cases being brought forward
- Markets demanding sustainable seafood





Illegal, Unreported, and Unregulated (IUU) Fishing

- 1 in 5 wild caught fish taken from the sea are taken illegally
- Annually, up to \$23.5 billon lost to illegal fishing
- IUU Hotspot: sub-Saharan Africa



IUU Fishing

Illegal Fishers Enjoy:

- Low risk high gain activity
 - Resource challenged, fish-rich states
- Patchy surveillance and enforcement
- Lack of information sharing by authorities
- No common global database on offenders





The Challenge

- Provide resource-poor officials access to up-to-date vessel information with single mouse click or text message
- Make it harder to land IUU fish
 - IMO numbers and Port State Measures
- Shift paradigm: proceedings against IUU vessel owners

Case Study: China in the Western and Central Pacific Tuna Fishery

- Participates in WCPFC as a full member
- WCPFC most "modern" of the tuna RFMOs
- Primarily as a DWFN targeting tuna
 - Longlines (219)
 - Purse seines (12)
- Access to Pacific Island EEZs via confidential agreements

China's Purse Seine Fishery in WCPFC







Figure 40. Catches by Chinese purse seiners

WCPFC Challenges

- Poor Data quality no verification system
 - Longline data often not available for 2 years
- Chartering arrangements in most Pacific Island
 Countries Chinese activities flagged offshore
- Uneven playing field heavily subsidized fleet
- Non-transparent Access Agreements
 - Often linked to aid ("checkbook diplomacy")
- Image Problem complicating relationships
