**Janet Ballantyne,** Deputy Assistant Administrator, Latin America and Caribbean Program , USAID

Janet Ballantyne is the Acting Deputy Assistant Administrator of the Latin America and the Caribbean program at the U.S. Agency for International Development (USAID), where she spent 28 years as a Foreign Service Officer. Before returning to USAID, she was the Group Vice President for International Development at Abt Associates, Inc. She holds the rank of career minister in the Senior Foreign Service. In her last position, Ballantyne served as Counselor and Acting Deputy Administrator. From 1996–1999, she was the USAID mission director for Russia. Her previous experience also includes serving as: senior deputy administrator for USAID's Bureau Policy and Program Coordinator (1995–1996); deputy assistant administrator and director, Center for Economic Growth (1994–1995); mission director for Nicaragua (1990–1994), and deputy director for USAID missions in Morocco and Nepal. Ballantyne has also served as a professor of National Strategic Policy Studies at the National War College. She received a bachelor's degree and a doctorate in international business from Cornell University.

**GEOFF DABELKO,** DIRECTOR. ENVIRONMENTAL CHANGE AND SECURITY PROGRAM, WOODROW WILSON CENTER

Geoffrey D. Dabelko is director of the Environmental Change and Security Program (ECSP), a nonpartisan policy forum on environment, population, health, and security issues at the Woodrow Wilson International Center for Scholars. Dabelko is also an adjunct professor at the Monterey Institute of International Studies. He has held prior positions with the Council on Foreign Relations and Foreign Policy and served as a lecturer at Georgetown University's School of Foreign Service. His current research focuses on environmental pathways to confidence-building and peacemaking, with a special emphasis on managing transboundary fresh water resources. Dabelko is principal investigator for ECSP's "Navigating Peace: Forging New Water Partnerships" initiative. He is co-editor of Environmental Peacemaking (2002) and Green Planet Blues: Four Decades of Global Environmental Politics (4th edition forthcoming 2010). He is also editor of the annual Environmental Change and Security Program Report; a member of the UN Environment Programme's Expert Advisory Group on Environment, Conflict, and Peacebuilding, and co-vice chair of the Scientific Committee of the International Human Dimensions Programme on Global Environmental Change (IHDP), and others. Dabelko received a Ph.D. in government and politics from the University of Maryland.

**Julie L. Kunen,** Senior Advisor, Bureau of Policy, Planning, and Learning, USAID

Julie L. Kunen is senior advisor and chief of staff in USAID's Bureau of Policy, Planning, and Learning (PPL). ### MARIA CARMEN LEMOS, ASSOCIATE PROFESSOR, NATURAL RESOURCES AND ENVIRONMENT, UNIVERSITY OF MICHIGAN

Maria Carmen Lemos is an Associate Professor of Natural Resources and Environment at the University of Michigan. She has taught at the University of Michigan since 2002, where she previously served as an Assistant Professor and a Faculty Associate. Prior to her work at the University of Michigan, Lemos worked as a Professor at the University of Arizona's Latin American Area Center from 1998-2002. Lemos' work has been featured in many publications such as the Journal of the American Water Resources Association, Revista Ambiante and Sociedade, and the Bulletin of Latin American Research. She has also co-authored many publications including: Technical knowledge and democratic decision-making: building adaptive capacity of fresh water systems in Brazil and The Watermark Project: Analyzing Water Management Reform in Brazil. Lemos has had the honor of receiving the James Martin 21st Century School Fellowship from Oxford University and the Kavli Fellowship from the U.S. National Academy of Sciences, among others honors. Lemos earned her Ph.D. and MSc. in Political Science from the Massachusetts Institute of Technology, and holds a Bachelor of Science in Economics from the Universidade Federal de Juiz de Fora in Brazil.

# **JUDITH MORRISON,** SENIOR ADVISER, GENDER AND DIVERSITY UNIT, INTER-AMERICAN DEVELOPMENT BANK

Judith Morrison currently serves as the Senior Adviser of the Gender and Diversity Unit at the Inter-American Development Bank. Previously, Morrison was the executive director of the Inter-Agency Consultation on Race in Latin America at the Inter-American Dialogue. She has also served as Director of the Brazil program at the Inter-American Foundation and as the division chief for the Eastern South American, Southern Cone, and Caribbean Regions. What is more, she has presented on issues of race and gender before expert panels in the U.S., South Africa, and throughout Latin America. Since 1998, Morrison has negotiated over 10 million dollars in social investment agreements with U.S. and Latin American steel, defense, automobile, consumer goods, and manufacturing industries. She has also published numerous articles on the political history of Latin America with Harvard University. Morrison earned her Master's degree in income distribution and poverty alleviation from the Massachusetts Institute of Technology, where she graduated with a Carroll Wilson Award for international research and a Woodrow Wilson fellowship.

### ERIC OLSON, SENIOR ASSOCIATE, MEXICO INSTITUTE, WOODROW WILSON CENTER

Eric L. Olson is a Senior Associate at the Mexico Institute of the Woodrow Wilson International Center for Scholars. In this position, he oversees the Institute's work on U.S.-Mexico security cooperation and research on organized crime and drug trafficking between the U.S., Mexico, and Central America. Prior to joining the Wilson Center, he was a Senior Specialist in the Department for Promotion of Good Governance at the Organization of American States from 2006-2007. Prior to Amnesty, he was the Senior Associate for Mexico, and Economic Policy at the Washington Office on Latin America for eight years. He worked at Augsburg College's Center for Global Education in Cuernavaca, Mexico from 1989-1993, where he was the program director. From 1986-1988, he worked in Honduras as a development specialist for several local non-governmental organizations. Olson has testified before the United States Congress on several occasions, appeared in numerous press stories as an expert commentator on human rights, drug policy, and organized crime. He has also written extensively on U.S.-Mexican relations, democratic and electoral reform in Mexico, and U.S. counternarcotics policy, and Colombia.

Christine Pendzich is an environmental specialist with over 20 years' experience in the environmental and climate field, with direct substantive and project experience in forests and climate, water, biodiversity conservation, land administration projects, and community management of natural resources. She currently serves as Climate Change Advisor to USAID's Bureau for Latin America and the Caribbean. **Blair Ruble**, Chair, Comparative Urban Studies Project, Woodrow Wilson Center

Blair Ruble is the Chair of the Comparative Urban Studies Project at the Woodrow Wilson Center, as well as the Director of the Wilson Center's Kennan Institute. Ruble's recent work has focused on urban management and regional development, specifically in post-Soviet Russia. Previously, Ruble served as a Staff Associate at the Social Science Research Council and the Assistant Executive Director at the National Council for Soviet and East European Research. He has also produced many noteworthy publications, including the following works: Creating Diversity Capital: Transnational Migrants in Montreal, Washington, and Kyiv, Second Metropolis: The Politics of Pragmatic Pluralism in Gilded Age Chicago, Silver Age Moscow, and Meiji Osaka, and Money Sings: The Politics of Urban Space in Post-Soviet Yaroslavl. In addition, Ruble received the Russian Federation's Presidential Medal for Contributions to the City of St. Petersburg in 2004, the United States Vice-President's "Hammer Award" for Reinventing Government in 1999, and was invited to the Kyoto University School of Law as an honored Dean's Guest in 1989. Ruble received his Ph.D. and Masters in Political Science from the University of Toronto, and holds an A.B. in Political Science from the University of North Carolina at Chapel Hill.

### PAULO SOTERO, DIRECTOR, BRAZIL INSTITUTE, WOODROW WILSON CENTER

Paulo Paulo Sotero Marques is the director of the Brazil Institute of the Woodrow Wilson Center. From 1989 until he joined the Wilson Center, on 2006, he was the Washington correspondent for *Estado de S. Paulo*, a leading Brazilian daily newspaper. He has also been a regular commentator and analyst for the BBC radio Portuguese language service, Radio France Internationale, and is a contributor to newspapers, magazines and scholarly journals. From 2003 to 2006, he served as adjunct lecturer at Georgetown University Center for Latin American Studies of the Edmund A. Walsh School of Foreign Service. In 2009, he joined the adjunct faculty of the Elliott School of International Affairs, George Washington University. A native of São Paulo, he started his career in journalism at Veja weekly magazine in 1968 and held positions in Recife, Paris, Lisbon, São Paulo, and Brasília. In Washington, he worked also as correspondent for Istoé weekly magazine and the financial daily Gazeta Mercantil. He is a member of the Maria Moors Cabot Prize Board, the Grupo de Conjuntura Internacional, a forum of discussion of Brazilian foreign and trade policies at the University of São Paulo, and the Fernando Braudel Institute of World Economics, also based in São Paulo.
