André Nassar has served as the director-general of ICONÉ since 2003. He has served as a leading agricultural economist on various projects, including as a member of the Brazilian Technical Group for Doha Round agricultural negotiations coordinated by the Ministries of External Relations and Agriculture of the Brazilian Government and on a G-20 expert committee commissioned by the Brazilian government to study agricultural world markets. From 1999 to 2002, Dr. Nassar was a senior researcher at the Economic Research Foundation (FIPE) and associate faculty member at the Agribusiness Studies Program (PENSA) of the University of São Paulo. In 2001 he was a visiting scholar at Georgetown University's School of Foreign Service. He earned a MS degree and PhD from the School of Economics and Business at the University of São Paulo (USP) and a BS in agronomy from the Luiz de Queiroz School of Agriculture at USP/ESALQ.
