### STEPHEN MERRILL, EXECUTIVE DIRECTOR, U.S. NATIONAL ACADEMY OF SCIENCE

Stephen Merrill has been Executive Director of the National Academies' Board on Science, Technology, and Economic Policy (STEP) since its formation in 1991. Dr. Merrill's association with the National Academies began in 1985, when he was principal consultant on the Academy report, Balancing the National Interest: National Security Export Controls and Global Economic Competition. In 1987, he was appointed to direct the Academies' first government and congressional liaison office. Previously, Dr. Merrill was a fellow in International Business at the Center for Strategic and International Studies (CSIS), where he specialized in technology trade issues. For seven years until 1981, he served on various congressional staffs, most recently that of the Senate Commerce, Science, and Transportation Committee. In 2005 he received the National Academy of Sciences Distinguished Service Award and was named one of the 50 most influential people worldwide in the intellectual property field by Managing Intellectual Property magazine for his work on STEP's A Patent System for the 21st Century (2004) project. Dr. Merrill holds degrees in political science from Columbia (B.A., summa cum laude), Oxford (M. Phil.), and Yale (M.A. and PhD.) Universities.

### Rahim Rezaie, PhD Candidate, McLaughlin-Rotman Centre for Global Health

Rahim Rezaie is a PhD Candidate at the University of Toronto's McLaughlin-Rotman Centre for Global Health. His previous education includes a specialist degree in cell and molecular biology, a minor in psychology and a masters degree in biotechnology. His practical experiences include genetic diagnosis of a host of hereditary conditions, and pharmaceutical regulatory affairs. His current research is focused on the role of domestic private sectors in Brazil, India and China in health product innovation and exploring the role of domestic private sector health biotechnology enterprises in developing countries in addressing local and global health needs. Rezaie is a co-author of the recent article, "Brazilian health biotech—fostering crosstalk between public and private sectors," published in the June 2008 edition of the influential journal *Nature Biotechnology*.

Michael P. Ryan, PhD, is director of the Creative and Innovative Economy Center at the George Washington University Law School, where he is coordinating and participating in a variety of research projects regarding the political economy, business, law, diplomacy, and ethics of creativity, innovation, and economic development in Africa, Asia, Latin America, and the Middle East. He is presently writing two books, *Knowledge Development: Creativity, Innovation, and the International Political Economy of Intellectual Property* and *Knowledge Ethics: Responsibility, Innovation, Governance, and AIDS in Africa* and he is the author of *Knowledge Diplomacy: Global Competition and the Politics of Intellectual Property* and *Playing by the Rules: American Trade Power and Diplomacy in the Pacific.* Dr. Ryan lectures frequently in Geneva to members of the diplomatic community and has lectured and conducted research in many developing countries. He has served on the faculties of the Georgetown University School of Foreign Service and School of Business and the University of Michigan Business School; has been a guest scholar at the Brookings Institution and a guest lecturer at China University of Law and Political Science; holds a PhD from the University of Michigan and an MA from The Ohio State University.
