**Speakers' Biographies**

**Cynthia Arnson** is director of the Latin American Program at the Woodrow Wilson International Center for Scholars. She is editor of *In the Wake of War: Democratization and Internal Armed Conflict in Latin America* (forthcoming, 2011); editor of *Comparative Peace Processes in Latin America* (Woodrow Wilson Center Press and Stanford University Press, 1999); co-editor (with I. William Zartman) of *Rethinking the Economics of War: The Intersection of Need, Creed, and Greed*, and author of *Crossroads: Congress, the President, and Central America, 1976-1993*. Arnson is a member of the editorial advisory board of *Foreign Affairs Latinoamérica* and a member of the advisory board of Human Rights Watch/Americas. She writes frequently on Colombia and U.S.-Colombian relations and holds an M.A. and Ph.D. in international relations from The Johns Hopkins University School of Advanced International Studies.

**Javier Corrales** is associate professor of Political Science at Amherst College in Amherst, Massachusetts. He has also been a consultant for the World Bank, the United Nations, the Center for Global Development, Freedom House, and the American Academy of Arts and Sciences. Corrales is the author of *Presidents without Parties: The Politics of Economic Reform in Argentina and Venezuela in the 1990s* and co-editor of *The Politics of Sexuality in Latin America*. His research has been published in academic journals such as *Comparative Politics*, *World Development*, and *Political Science Quarterly*. He serves on the editorial board of *Latin American Politics and Society* and the *Americas Quarterly*. Corrales holds a Ph.D. in Political Science from Harvard University, and specializes in the politics of economic and social policy reform in developing countries.

**Jorge Domínguez** is the Antonio Madero Professor of Mexican and Latin American Politics and Economics, Vice Provost for International Affairs, senior advisor for International Studies to the Dean of the Faculty of Arts and Sciences, and chairman of the Harvard Academy for International and Area Studies at Harvard University. He is the author or co-author of numerous books and articles on domestic and international politics, including *The Construction of Democracy: Lessons from Practice and Research*, *Cuba hoy: Analizando su pasado, imaginando su futuro*, and *The United States and Mexico: Between Partnership and Conflict* (second edition). A past president of the Latin American Studies Association and a past board chairman of the Latin American Scholarship Program of American Universities, Domínguez currently serves on the editorial boards of *Political Science Quarterly*, *Foreign Affairs Latinoamérica*, *Cuban Studies*, and *Foro Internacional*. Professor Domínguez holds a B.A. from Yale University and received his M.A. and Ph.D. from Harvard University.

**Cynthia McClintock** is a professor of Political Science and International Affairs and the director of The George Washington University's Latin American and Hemispheric Studies Program. She was previously a fellow at the Woodrow Wilson International Center for Scholars and President of the Latin American Studies Association. McClintock's most recent book is *The United States and Peru: Cooperation—at a Cost*. Previous books include *Revolutionary Movements in Latin America: El Salvador's FMLN and Peru's Shining Path*, and *Peasant Cooperatives and Political Change in Peru*. She holds a B.A. from Harvard University and a Ph.D. from the Massachusetts Institute of Technology.
