Dian DeGette is a Democratic Member of the U.S. House of Representatives from the First Congressional District of Colorado since 1997. She is vice chair of the Committee on Energy and Commerce where she serves on three subcommittees, including the Subcommittee on Health. She is also a member of the House Committee on Natural Resources. In 2005 she was appointed to the House Democratic leadership as Chief Deputy Whip after serving six years as regional whip. Prior to her election to Congress she served two terms in the Colorado House of Representatives where she served as Assistant Minority Leader from 1993-1995. She received her B.A. from Colorado College and her J.D. from New York University School of Law.

Mike Rogers is a Republican Member of the U.S. House of Representatives from the Eighth Congressional District of Michigan since 2001. He is a member of the Energy and Commerce Committee, including its Subcommittee on Health, and is also a member of the House Permanent Select Committee on Intelligence. He is a veteran of the U.S. Army where he served as an officer and company commander, and a former agent of the Federal Bureau of Investigation where he served on the Chicago Bureau's organized crime unit. He is a graduate of Adrian College in Michigan and of the University of Michigan Reserve Officer Training Corps.
