Endangered Species Act 1972

Nonindigenous Aquatic Nuisance Prevention and Control Act (NANPCA) of 1990

National Invasive Species Act 1996-2002 (focused on aquatics)

Plant Protection Act 2000

Aquatic Nuisance Species Task Force (FWS and NOAA) and six regional panels

Lacey Act (1990): prohibits certain imports including Asian Carp

Chapter Three of Title 18, including extraterritorial jsdn

National Invasive Species Council

- * <u>Created 1999</u>
- * Secretaries of the Interior, Agriculture, and Commerce.
- * NISC members include the Secretaries of State, Defense, Homeland Security, Treasury, Transportation, Health and Human Services, the U.S. Trade Representative (USTR), as well as the Administrators of the EPA, NASA, and USAID.
- * provides high-level interdepartmental coordination of federal invasive species actions and works with other federal and non-federal groups

Canada

(provincial jurisdiction over most natural resources)

- * Canada National Parks Act; Canada Shipping Act; Canada Wildlife Act; Canadian Environmental Protection Act; Canadian Environmental Assessment Act; Department of Natural Resources Act; Fisheries Act; Forestry Act; Oceans Act; Pest Control Products Act; Plant Protection Act; Seeds Act; Transportation of Dangerous Goods Act; Wild Animal and Plant Protection and Regulation of International and Interprovincial Trade Act
- * Parks Canada; CFIA; Environment Canada; RCMP;
 Agriculture and Agri-Food Canada, Canada Border Services
 Agency, DFO, NRC, Transport Canada
