- 3) limited risk reduction capacity.





# Urban Africa Risk Knowledge

### Transitioning the risk-development nexus: blockages, enablers and pathways



Moving risk management from its position as a minor concern removed from mainstream development to understanding development as a core concern for risk management and breaking cycles of risk accumulation:

- Constraints: existing donor priorities, fragmented city governance and data and monitoring gaps.
- Enablers: Movement is observed where risk and data forecasting, locally accountable leadership and community networks collaborating with city authorities are found.
