

Galina Starovoitova Fellowship at the Kennan Institute—Instructions for Applicants This document contains instructions and the application form for the Kennan Institute Galina Starovoitova Fellowship. Please take a moment to review the various research grants offered by the Kennan Institute on our web site: (www.wilsoncenter.org/kennan). After reviewing the list, should you decide that you would rather apply for one of the Institute's other grant programs, please download the proper application form. Please keep in mind that the Starovoitova Fellowship, which is funded by the Bureau of Educational and Cultural Affairs of the United States Department of State, is restricted to citizens of the Russian Federation residing either in or outside of Russia at the time of application.

Applicants must be eligible to obtain a J-1 exchange visitor visa.

In keeping with both the legacies of Woodrow Wilson and Galina Starovoitova, the Starovoitova Fellowship is available to prominent scholars and policy makers from the Russian Federation who have successfully bridged the worlds of ideas and public affairs to advance human rights, the rule of law, conflict resolution, the free press, and civil society. Applicants with outstanding capability and experience from a wide variety of backgrounds (including government, journalism, the professions, NGOs, and academia) are eligible for appointment. For academic participants, eligibility is limited to the postdoctoral level, and normally it is expected that academic candidates will have demonstrated their scholarly development by publication beyond the *Kandidat* dissertation. For other applicants, an equivalent level of professional achievement is expected.

Under the terms of the grant, the Galina Starovoitova Fellowship offers a monthly stipend of \$3,500, research facilities, computer support, and research assistance. Grant recipients are required to be in residence at the Kennan Institute in Washington, D.C. for the duration of their grant. Starovoitova Fellows are expected to hold public lectures on the themes of conflict resolution and human rights while conducting research on a specific topic. In addition, Starovoitova Fellows will actively participate in discussions with the public policy and academic communities, including giving speeches and lectures at other institutions and taking part in meetings and conferences.

The Application

A complete application must include the following:

- 1. the following Application Form
- 2. a project proposal (not to exceed 2,000 words)
- 3. a one-page bibliography for the project
- 4. a list of your publications (not to exceed three pages)
- 5. a curriculum vitae
- 6. three letters of recommendation

Applications should be submitted as PDF files by email. Please contact Kennan Staff (kennan@wilsoncenter.org) if you are unable to submit documents by email. Do not send sample publications.

THE PROJECT PROPOSAL OF NO MORE THAN 2,000 WORDS IS THE MOST IMPORTANT ELEMENT IN THE SELECTION PROCESS. It is essential that you make your project clear to individuals outside your own field and to explain its broader implications, including policy relevance.

The elements requested below should be incorporated into the text:

- 1. a detailed description of the topic and its policy relevance beyond the interests of the specific field of study,
- 2. the originality of the proposed study,
- 3. the basic ideas and hypotheses,



- 4. the methods or approaches to be used,
- 5. a brief discussion of how you your project will foster communication between the world of ideas and the world of public affairs.

Letters of Recommendation

It is your responsibility to have three signed letters of reference sent directly to the Kennan Institute by the deadline. Scanned copies of signed letters sent to us by email are acceptable. Your referees should be familiar with you and your work. Along with a copy of your proposal, you should send to your referees a copy of the enclosed letter of instruction, which they can use in preparing their comments about your proposed study and your qualifications for undertaking it. They may also comment upon how you and your work would contribute to the Center's goal of bridging the gap between the worlds of scholarship and public affairs.

Deadline: All application materials must be received by May 15.

Applications will be reviewed by an expert committee. Successful applicants will proceed to a second round of selection, consisting of an interview. Final results will be announced during the fall.

BACKGROUND: THE GALINA STAROVOITOVA FELLOWSHIP ON HUMAN RIGHTS AND CONFLICT RESOLUTION

The Galina Starovoitova Fellowship on Human Rights and Conflict Resolution was established following U.S. Secretary of State Madeleine Albright's 25 January 1999 speech in Moscow in which she announced funding for a memorial fellowship at the Kennan Institute of the Woodrow Wilson International Center for Scholars in honor of Galina Starovoitova. The Fellowship is funded and administered in cooperation with the Bureau of Educational and Cultural Affairs of the U.S. Department of State and the Public Affairs office of the U.S. Embassy in Moscow.

Galina Starovoitova was a leading human rights advocate and a deputy in the Russian lower house of parliament (Duma). She won her Duma seat from St. Petersburg in Russia's December 1995 legislative elections. Starovoitova served in the Congress of Peoples' Deputies during 1989-91 and was a presidential advisor on ethnic relations until 1992. She was a co-founder of the Democratic Russia movement. In 1989, Galina Starovoitova was a visiting scholar at the Kennan Institute of the Woodrow Wilson International Center for Scholars. She was also a fellow in the Jennings Randolph fellowship program at the United States Institute for Peace during 1993-94, where she completed research on self-determination movements in the former Soviet Union, and a visiting professor at Brown University.

In keeping with the legacy of Galina Starovoitova, the Starovoitova Fellowship is available to prominent scholars or policy makers from the Russian Federation who have successfully bridged the worlds of ideas and public affairs to advance human rights the rule of law, conflict resolution, the free press, and civil society. Each year, a Starovoitova Fellow is chosen to be in residence at the Kennan Institute to conduct research on projects related to those fields.

The applicant has identified you as one of the three individuals who are familiar with the applicant's work and qualifications and who would be asked to comment specifically on the proposed study and the applicant's ability to undertake it.

We would appreciate receiving from you a full and candid evaluation both of the candidate and of the proposed study project. The basic criteria for selection of scholars are: 1) the importance and originality of the project to the fields of human rights and conflict resolution (the quality of the project proposal and the degree to which the key questions have been identified and a promising approach outlined), 2) the applicant's scholarly capabilities, achievement, and the ability to accomplish the proposed project, and 3) the likelihood that the work, when completed, will advance basic understanding of the topic under study and represent a substantial contribution to the body of knowledge about it.

You should also be aware that the Kennan Institute and the Wilson Center strive to encourage active scholarly dialogue and exchange of views and perspectives among fellows and between them and the public at large. While working on their projects, fellows are also members of an intellectual community who are encouraged to participate in the institutional life of the Wilson Center in both formal and informal ways, ranging from informal conversations to involvement in the Center's meetings, colloquia, and conferences. It is with this background in mind that we ask for your opinion as to whether the applicant would contribute to the community life of the Institute and of the Center as a whole.

Please send your letters of recommendation by the deadline of **May 15** directly to the Kennan Institute. Please send a scanned copy of your letter to (<u>kennan@wilsoncenter.org</u>). Letters of recommendation are crucial to the evaluation process, and we, no less than the candidates themselves, appreciate the care and attention that you will have devoted to the matter.
