SPOTLIGHT: AFGHANISTAN I HINDSIGHT UP FRONT

Wither Afghanistan after the U.S. withdrawal? The rapid collapse of the Afghan military and the resignation of its government startled the world by returning the Taliban to national power after nearly two decades of conflict.

The Wilson Center's Hindsight Up Front initiative drew from the deep expertise in residence at the Center – rated best in the world for regional studies for several years – to examine the implications of what is unfolding for Afghanistan, its people, the region, and the United States.

Hindsight Up Front has featured strategic discussions with key leaders (former National Security Advisor HR McMaster, as well as former CIA Director David Petraeus and former MI-6 Chief Sir John Scarlett), as well as informed commentary, analysis and video content to give a fuller picture of a major geopolitical event.

SPOTLIGHT: SUPPLY CHAINS

Highly efficient supply chains ushered in and enabled unprecedented levels of consumption and wealth creation. However, they are increasingly subject to disruption and even catastrophic failure, particularly in the face of anomalous events such as cyber-attacks, security threats, global pandemics, technological innovation, and spikes in geopolitical tension.

The risks specific to the supply chains of products crucial to national and economic security – critical minerals, advanced semiconductors, medical devices and equipment, electric vehicles, and other green technologies – are particularly acute.



The Wilson Center's Critical Supply Chains Initiative is a stakeholder-focused dialogue process that focuses on governance and technology as tools to strengthen trust in U.S. supply chains, and to counter the many threats that continue to exist in this area.





SPOTLIGHT: USMCA

THE USMCA AT ONE YEAR

The United States Mexico Canada Agreement (USMCA) entered into force on July 1, 2020, replacing the North American Free Trade Agreement (NAFTA) that had governed trade and guided cooperation among the three federal governments for 25 years.

It was a momentous first year for the agreement in many ways. The USMCA was

SPOTLIGHT: HUMANITY IN MOTION

With more than 82 million people worldwide recognized as a refugee, asylum seeker, or internally displaced, the human displacement crisis is one of the most pressing issues of global governance today. Understanding the history of displacement and today's complex challenges through bi-partisan scholarship is essential to get beyond the often-inflammatory headlines.

Our examination began with an event featuring Colombia President Iván Duque Márquez, who welcomed scores of Venezuelan refugees, and continued with an unprecedented issue of the *Wilson Quarterly*, which included insights from President Duque, King Abdullah II of Jordan, Rep. Henry Cuellar of Texas, Sen. Claudia Ruiz-Massieu of Mexico, and David Beasley and Henrietta Fore of the World Food Programme and UNICEF. Scholars, journalists, and current and former refugees rounded out our global coverage of displacement's key drivers – conflict, climate, and poverty – and innovative solutions.

Our key takeaway: it will take humanitarian and development approaches to ensure displaced people are treated with dignity, and they and their host communities emerge stronger.

Gathering Voices and Visions





Until all countries are safe from the COVID-19 virus no country is safe. **Former UK Prime Minister Tony Blair** spoke in May 2021 on the urgent need to accelerate production and distribution of COVID-19 vaccines.

Former National Security Advisor H.R. McMaster spoke about U.S. withdrawal from Afghanistan and its implications for future U.S. policy to ensure that U.S. interests in Afghanistan continue to be advanced.

Global Advisory Council co-chairs **Gen. David Petraeus** (Former Commander, U.S. and NATO Forces in Afghanistan) and **Sir John Scarlett** (Former Chief of MI6) kicked off the Wilson Center's Hindsight Up Front initiative on Afghanistan.



President Lenín Moreno of Ecuador spoke on his nation's efforts to battle the COVID-19 pandemic as part of the Latin American Program's Crisis Conversations.









President Luis Abinader of the Dominican Republic, used a conversation at the Wilson Center to stress the high priority his nation placed on relations with the United States.

> Interim President Francisco Sagasti of Peru made the twin battles he faced as that nation's leader – a political crisis and COVID-19 – the center of his Wilson Center appearance.

Panama's progress in tackling challenges in migration, organized crime, and drugs were at the forefront of **President Laurentino Cortizo**'s Crisis Conversation at the Wilson Center.

In an exclusive Wilson Center event, **President Iván Duque Márquez** spoke directly about the challenges posed by civil unrest and pandemic in Colombia, and articulated his vision of the way forward.

U.S. Senator Sheldon Whitehouse (with Polar Institute Director Mike Sfraga) discussed the shape of environmental policy in Antarctica, noting that "things are happening faster in the Arctic than anywhere else."

Informing Congress





Disinformation Fellow **Nina Jankowicz** testified before the House Armed Services Subcommittee on Cyber, Innovative Technologies, and Information Systems, calling for a comprehensive, long-term defense plan related to disinformation, which continues to threaten public health, safety, and the democratic process.

Abe Denmark testified before the U.S.-China Economic and Security Review Commission about China's nuclear forces. His testimony focused on the state of the U.S.-China nuclear relationship; allied and partner views of China's nuclear modernization; and ensuing recommendations for U.S. policy.

Meg King, then Director of the Science and Technology Innovation Program, testified before the House Financial Services Committee's Taskforce on Artificial Intelligence, offering her expertise about current ethical AI frameworks, how to make AI ethics more practical, and what happens when AI breaks.

Public Policy Fellow **Hallam Ferguson** testified before the House Foreign Affairs Middle East, North Africa, and Global Counterterrorism Subcommittee about COVID-19 in the MENA region, addressing the impacts of the pandemic and the road to recovery. "We have decided to make a very bold move based on principles, which is to embrace the 1.8 million brothers and sisters that have left Venezuela with frozen bones, lacking the access to many services, ...it is our moral duty to allow them to have access to opportunities in Colombia."

Global Action Across Programs



The Africa Program and the State Department co-hosted the 10th Anniversary Summit of the Young African Leaders Initiative (YALI), the USG's

signature program for investing in Africa's youth. The event showcased YALI's impact and demonstrated the USG's commitment to Africa's youth and was attended by over 5000 people. The Program also published:

The State of Peacebuilding in Africa: Lessons Learned for DUNG Policymakers and Practitioners. The book has been downloaded



The Asia Program focused on delivering insight and analysis on rapid changes facing the Indo-Pacific and the impact of ongoing U.S. tensions with China across the

region. From hosting discussions with Taiwan's senior government officials to addressing the challenges of economic security in Asia, the Program continued to provide forums for dialogue on issues confronting the world's most populous region. The Asia Program also spearheaded a weekly series, Hindsight Up Front, to assess the implications of U.S. withdrawal from Afghanistan and the outlook for U.S. engagement in the region.

The Canada Institute launched a Task Force on Public Health and the U.S.-Canadian Border and worked with the Mexico Institute to assess USMCA implementation. After the U.S. election, Wilson scholars identified 22 urgent

bilateral issues for the new U.S. Administration. Many of these issues were prominent in a "roadmap" agenda signed by President Biden and Prime Minister Trudeau in February. A snap Canadian election in September generated new attention to U.S.-Canadian relations.



The Kissinger Institute focused on the global implications of U.S.-China competition by co-hosting monthly dialogues with Asian allies, European allies, and China itself. Its policymaker and corporate briefings, programs, seminars, and media hits

involved collaboration with experts and institutions in over thirty countries. The insights and networks developed through the internationalization of the Kissinger Institute have positioned it to build the leading online platform on the worldwide impacts of U.S.-China relations.



As climate impacts mount, the Biden Administration is taking steps to put the climate crisis "at

the center of U.S. foreign policy and national security." Drawing on decades of research and analysis, the Environmental Change & Security Program provided critical guidance to U.S. policymakers on how to meaningfully integrate climate security into U.S. foreign policy, development assistance, and national security.





The China Environment Forum and Serious Games Initiative are leading work to protect our oceans by creating The Plastic Pipeline, an innovative

digital game designed to address the knowledge gap around plastic pollution solutions. SGI leads the design and CEF does the extensive

research into policy, industry, and community innovations to stem ocean plastic leakage.





In 2021 the Global Europe Program has reaffirmed its commitment to analyzing the global role played by Europe in the issue areas

of security, trade, energy, climate, and the digital economy. With over 64 publications, GEP has continued to make significant contributions to Washington's understanding of Europe's place in the world.





The History and Public Policy Program continued to shape public policy debate, academic research, and classroom discussions through its Digital Archive. The platform reached over 275,000 users who

logged more than 1.4 million page views in 2021. New accessions to the Digital Archive include collections on Cold War disinformation, nuclear proliferation, the Space Race, Chinese foreign policy, and more.



The Kennan Institute's Resurgent Russia Briefing Series convened congressional staff to participate in roundtable conversations with our experts to explore Russia's foreign policy towards its immediate neighbors, its

strengthening partnership with China, and its ambitions to develop the Arctic. The Institute also added new forms of digital outreach, including infographics on our publications and recent events, and Kennan Xplainer animated videos delving into important issues and events related to Russia.



The Maternal Health Initiative explored COVID-19's devastating effects on women, girls, and people of color in high-level symposiums,

including a conversation with Representative Alma Adams (D-NC). Since 2020 was also the International Year of the Nurse and Midwife, MHI also focused on front-line health workers, specifically midwives and nurses, as they lead the fight against COVID-19.



As environmental threats deepen, the Brazil Institute launched a nongovernmental Brazil-U.S. Dialogue among business leaders, civil society, and former policymakers to foster stronger collaboration on Amazon deforestation and sustainable

development. The Latin American Program hosted the environment ministers from Argentina, Chile, and Colombia and senior State Department and UN officials to discuss coordinated action on addressing climate change.

Director Mike Sfraga's conceptual framework, Navigating the Arctic's 7 Cs, was released in October as a monograph. Several experts explained the nuances and complexities of the

challenges and opportunities in the Arctic through the lens of Climate, Commodities, Commerce, Connectivity, Communities, Cooperation, and Competition. The framework has already been referenced by a wide variety of Arctic stakeholders in Washington, DC, Alaska, and the global Arctic.





The Mexico Institute has engaged government officials, businesses, experts, and civil society in both countries through our monthly USMCA dialogues, examining the implementation of the trade agreement

in North America. The Institute's work focused on Mexico's mid-term elections, binational security, agricultural labor, the impact of COVID-19 on the border region, and, in collaboration across programs, genderbased violence, and environmental issues.



In 2021 the Middle East program explored the most critical events shaping the region. High level discussions were held on Gaza, the Abraham Accords, and digital transformation in MENA. The *Building a Better Lebanon*

report examined the multifaceted crisis in Lebanon and offered recommendations to policymakers. The program officially launched the podcast, *Riyada*, featuring entrepreneurs and innovators

in MENA. Finally, MEP acknowledged important milestones, marking 10 years since the Arab uprisings with a special publication series, and video blogs with experts to commemorate the UN's *16 Days of Activism* against Gender-Based Violence.





The Science and Technology Innovation Program recently launched a new initiative, Across Karman, bringing you global insights and analysis on space technology and policy.

As our dependency on space technology grows, it's clearer than ever: space matters. Across Karman aims to lead the conversation around space as a global policy issue by examining how the rapidly increasing commercialization of space impacts international collaboration across sectors.



Informing the Public
